# **Web Based Project Policies & Disclosures:**

# **Design & Buildout**

Web sites may vary from the actual design where necessary for responsive design, accessibility or other functionality limitations.

## **Responsibilities and Warranty**

Each web site project comes with a limited 30 day warranty. Within this time Hester Designs will maintain security, backups and Malware scans. Free limited technical support will also be available. Hester Designs is not responsible for web site issues related to problems caused by a client, hosting company or outside vendor. Clients are responsible for their web site operations, security, backups, hosting, updates, software, plug-ins, privacy ongoing. Web sites should be handled the same as a physical space and operations should be tested daily.

## **Voiding Your Warranty**

Not keeping your site up-to-date, adding plug-ins and custom development, changing code, styles or settings, or any other modification can result in problems and void the Hester Designs warranty.

# **Downtime / Failure Rate**

Web site and hosting platforms fail from time to time, or experience problems due to internet service outages, and other natural disasters out larger scale outages of power or network issues. It is not uncommon to experience an outage, and we suggest clients be prepared with other communication methods for public relations and notifications in such a situation. Hester Designs works hard to keep things operational 24/7, and your services are a top priority.

#### **Trouble Shooting & Technical Support**

Hester Designs can provide technical support for websites. This service is billed by the hour. Support is available during normal business hours and will be scheduled in order of requests. We strongly suggest backups be completed on an ongoing basis to assist if a problem occur.

# **Disaster Recovery**

Ultimately the recovery of a web site is up to the client and the resources put in place. We suggest every client develop a disaster recovery plan and share that with Hester Designs. Should your web site suffer as a result of a disaster or outage, upon client request and at additional cost, we would use client backups to resurrect the site, or migrate your site to a working server.

# **Archived Web Projects & Data Retention**

Hester Designs maintains archived project files for up to 30 days from the date of final project completion, only for active clients or clients enrolled in the WebSafe™ service. Upon termination of hosting,

maintenance, or other active services, any retained project files — including but not limited to database exports, editable source files, or backups—are permanently deleted in accordance with our security protocols, unless separate archival arrangements were made in writing and additional fees were paid. Requests for files or data from former clients whose accounts have been closed or inactive for more than 30 days will not be honored unless a formal archive retention agreement was executed. Hester Designs does not assume responsibility for maintaining access to client files or backups after the termination of services. Clients are strongly advised to maintain their own secure backups of all delivered files. Hester Designs is not liable for any losses resulting from a client's failure to do so.

# **Privacy Policy:**

All username and passwords are kept confidential at the time of project. All information used for projects and web hosting that may pose a security risk are deleted and/or shredded immediately after the project completion. Client information is never sold or used for solicitation of third party services. Hosting services are provided by TVCnet.com and clients should refer to their policies beyond the above, as disclosed in the Web Hosting Policies below.

#### WebSafe™ Service:

WebSafe Backup and Security is a monthly website maintenance, security, and information backup and recovery service provided by Hester Designs. This service provides clients the following:

- Installation and set up of Wordpress security plugins licensed to Hester Designs.
- Monthly updates of WordPress core, WordPress plugins, and Wordpress Design Themes. These
  updates are subject to up-to-date licensing fees in some cases.
- · Monthly scans for malware.
- · Monthly back-up of entire website and database.
- Storage of monthly backups.

WebSafe Backup and Security is provided at the current rate of \$55 month, with a 12 month contract. To discontinue this service requires 30 day notice. This service can be customized.

WebSafe Backup and Security intends to fulfill the following purposes:

- WordPress websites from being hacked by malware or hackers by blocking IP addresses of multiple failed login attempts in the WordPress login panel.
- Keep WordPress websites and their accompanying core, themes, and plugins up to date to minimize and security vulnerabilities.
- Minimize downtime and losses by quickly restoring a website in the event of a site being hacked.

Enrollment and use of WebSafe Backup and Security does not guarantee protection from malware, hacks or cyber attacks on your website. It does however help resurrect a site using parts or all of back up files available.

Hester Designs sells Hosting through the provider TVC. The following policies are transferred to Hester Designs hosting customers as part of TVC hosting services. At no time is TVC to be contacted directly in regards to hosting services. Always contact Hester Designs direct for support and service of your account.

#### Legal Usage:

Hester Designs & TVCNet reserves the right to remove any materials Hester Designs & TVCNet does become aware of that are, in Hester Designs & TVCNet' sole (but commercially reasonable) discretion, potentially illegal, could subject Hester Designs & TVCNet to liability, or violate this policy. The use of Hester Designs & TVCNet is subject to the following terms and conditions. Hester Designs & TVCNet services may not be used for illegal purposes, or in support of illegal activities. Hester Designs & TVCNet reserves the right to cooperate with legal authorities and/or injured third-parties in the investigation of any suspected crime or civil wrong. #### **Advertising & Image Policy:**

Hester Designs & TVCNet fully supports the Digital Millennium Copyright Act (DMCA). It is our policy to respond to notices of alleged copyright infringement in a timely manner, and take reasonable action in respect to the guidelines specified in the DMCA. Trademark disputes are not covered within the DMCA, and complaints related to U. S. trademark law will be e-mailed to the owner of the website account respectively. Pictures depicting nudity and/or content unacceptable for viewing or reading by minors is not allowed. Pornographic pictures, text, or domain names will be cause for immediate account termination or suspension without prior notification. Hester Designs & TVCNet may not be used to host the following related web sites: alcohol or tobacco; illegal drugs; hate groups; or web sites inappropriate for viewing by minors.

#### **Web Server Fair Use and Limitations:**

Use of server accounts for process-heavy jobs, such as MUD, IRC or IRC Bots, or bulk emailing scripts are not allowed. Cron processes should not be scheduled to run more than once per 10 minutes without express permission from Hester Designs & TVCNet staff. Scripts that have a perceivable affect on the stability or reliability of a shared web server will be disabled, and notice will be sent to the manager of the account accordingly. As a general rule, individual processes may not consume more than 500k of active memory, or consistently use more than 20% of available server processes. In order to prevent the abuse of server e-mail accounts, the sending of e-mail may be limited to 600 messages per hour. Clients may not run network processes that compromise our network or the network of others. While bursts of up to 40 Mbps (megabits per second) are allowed, servers will not exceed an average 10Mbps for a protracted period. Only one instance of Wordpress and software is allowed on hosting accounts.

# **Uptime Guarantee:**

If your hosting service has physical downtime that is not within 99.9% uptime for a given month you may receive one month of credit on your account. This does not include problems caused by your site or hosted files, including problems related to a hacked site or server account. Only dedicated server services are covered by a network guarantee in which credit is prorated for the amount of time the server is down due to issues within our control. Examples of issues outside our control may include denial of service attacks, domain name registry errors, or network connection issues outside of our network. This

does not include problems caused by your site or hosted files, including problems related to a hacked site or server account.

#### **Cancellation of services:**

30 days prior notice must be given to cancel a service. Notice can be sent via mail or email. The preferable method is to use our technical support form at HesterDesigns.com. If no notice is given then 30 days service will be due at the time of cancellation.
